Respected Seniors and Dear Colleagues, Greetings.

There were lot of installation ceremonies last month and hectic activities of wings and schemes, where our State President Dr. R. Palaniswamy and myself attended.

In the State level, we had a well-organized PPLSSS Management Committee Meeting in Tirunelveli by the local branch, where lot of discussions and fruitful decisions were taken, to be presented in the upcoming State Council Meeting in Kallakurichi for approval. The Trust Board is to be reconstituted with 1 member from each zone, either elected or rotated amongst the branches with a maximum tenure of 2 years.

We had our Finance Standing Committee meeting with a lot of recommendations by our FSC Chairman Dr. T. Senthamil Pari. As the fixed deposits are earning only 5%, whereas the inflation is more than 6.6%, we are losing value for money, the means and ways were discussed. The expenditure

of State office, Wings and Schemes were discussed in detail. The resolutions passed in the FSC will be placed in the SCM for approval.

The NHB Management Committee Meeting and the Zonal meeting was held at Erode on 20-2-2022 with a lot of participation and useful discussions on various problems being faced by our fraternity.

An Orientation/Faculty Meet-2022 of Paramedical Wing held on 20-2-2022 in Erode, where around 50 Principals/Faculties from 25 Paramedical Institutions were participated. Deliberations on the Curriculum to be followed and certain important points discussed, which will be placed in the forthcoming SCM for approval.

Concerning FSS, we are getting a lot of representations and suggestions which will be discussed threadbare and take this issue forward. The FSS Management Committee Meeting is to be held on 27th Feb 2022.

We are also having the Constitutional amendment committee meeting on the 26-2-2022 at Kumbakonam. We request the branch office bearers to send us the suggestions if any to be amended in the by-laws. We will also circulate the draft copy of the State by-law and also the proposed branch by-laws in the upcoming issue of TIMA, before finalising the same in the State Council meeting.

Congratulations to all the new office bearers of various branches who've taken up the responsibilities. I request the branch Presidents to convene a meeting of all empanelled hospitals in your district and discuss the rates quoted for the Government insurance schemes.

Concerning the scam, we will discuss on the status of the case and the charge sheet with our Lawyer and update you all on the all developments in the upcoming months as and when there is progress or any new developments. They have made a lot of suggestions, which were being followed diligently as it is subjudice and premature, but again will update at the earliest. Once again I'd like to reiterate that those responsible for this scam would be fixed and recovery would be initiated.

We have planned for Leadership orientation programme for the newly installed Presidents and Secretaries in Chennai on March 6th, the details will be communicated through e-mail. I request all the newly elected President and the Secretaries to attend the programme, which will be very useful in the days to come.

The State Women Doctors wing will be celebrating the Women's day on March 13th in Tirupur and I wish very Happy Women's day. Thanking you all for the kind cooperation. **Long live IMA.** ■

An Appeal

On 06-02-2022 we had Finance Standing Committee Meeting in which most of the FSC members actively participated.

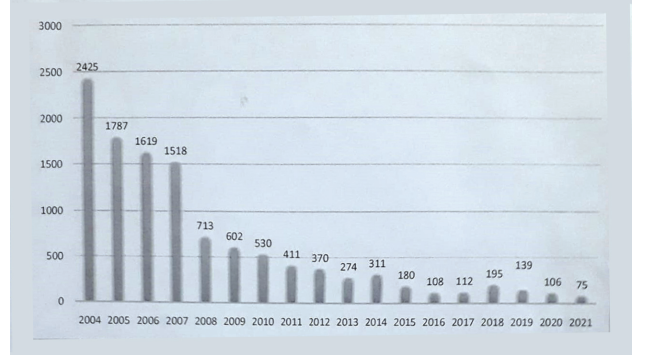
Regarding the said meeting, I wish to express my observations and opinions to all IMA members on financial management and financial status of various schemes, wings and IMA TNSB.

All account of Schemes, Wings and TNSB were thoroughly scrutinized and compared with bank accounts and also obtained explanations for various queries raised. I am of the opinion that finance of various schemes and wings were managed well by the respective office bearers. Financial status of PPLSSS is good with Fixed Deposit of Rs. 16,84,58,819/- (PPLSSS New + Renewal + Family Benefit Scheme + Hospital Protection Scheme). Guest houses are not running profitably. Suggestions were given to improve the standard of guest house and the relative rate of occupancy.

In FSS II, we have Rs.25 crores as fixed deposit and it is commendable. We have reduced the age limit for joining FSS II to 50 years. Hence there was no consequential pitfall in FSS II. Hope we can manage FSS II successfully without increase in AFC.

Regarding FSS I, I have the responsibility as FSC Chairman to explain the members of the actual financial status and as to why the NRD deposits were eroded, which is solely due to the excess death rate reported beyond our expectations during corona

pandemic. Herewith I present the graphical table to explain the declining ratio of membership growth from 2008 onwards.



We did not concentrate on this issue and take necessary steps to improve the membership. This is the obvious reason for facing the crisis financially at present. Corpus fund was eroded due to the following reason.

1. Excess death in less than 4 years alone
77 X Rs. 1, 80, 000 = Rs.13.85 crores
2. Scam amount = Rs.3.00 crores
Thus the total loss is 16.85 crores.

Consequentially at present we have corpus fund of only Rs.8 crores. Even though this is critical situation, the same is not only due to scam but also the excess death rate, declining membership growth are the important factors for this crisis.

Now we had received the opinions regarding FSS issue from branches. We are to analyze the recommendations from the branches and to decide appropriately to satisfy all members of FSS without any adverse impact to the scheme at the MCM scheduled on 27.02.2022 at Kumbakonam. Till that time, I humbly request my seniors with bowed hands to maintain resilience and please put the responsibilities confidently on our (office bearers) shoulders with to resolve this issue in a good and amicable manner.

World Glaucoma Week

March 6-12, 2022

Often referred to as the ‘**silent thief of sight**’, Glaucoma is a disorder that damages the optic nerve of the eye and may lead to permanent loss of vision.

According to WHO statistics, glaucoma is the leading cause of irreversible blindness in India with a prevalence of 2.6 per cent. After China and Europe, about 11.2 million people in India are affected with glaucoma- out of which 1.2 million are blind. Despite our yearly effort (World Glaucoma Week) to raise awareness about glaucoma, still lots of them are not even aware about the disease (only 9% of glaucoma patients are either aware that they have glaucoma or on treatment).

Introduction:

Glaucoma is a multifactorial diseases characterized by damage to the optic nerve. A healthy eye produces a fluid, called aqueous humor, at the same rate at which it drains. High pressure (raised intraocular pressure- IOP) occurs when the drainage system is blocked and the fluid cannot exit at a normal rate. The high eye pressure instead keeps building and pushing against the optic nerve which carries visual impulse to the brain. The extreme pressure can permanently damage axonal fibers leading to loss of peripheral field of vision.

Glaucoma can be primary (idiopathic or hereditary) or secondary (with a cause like steroid induced, pseudoexfoliation, pigment dispersion within the eye, neovascularization etc)

and it can be either open angle or closed angle disease. In case of open angle disease, aqueous flows upto the trabecular meshwork and filtration is either less and nil whereas in case of angle closure disease, the pathway to angle is either narrow or closed and the aqueous finds difficult to reach trabecular meshwork.

Risk Factors:

People over the age of 40, those suffering from diabetes, migraine, who frequently change their spectacles, who have high minus numbers, use steroids too often and most importantly those who have a family history of Glaucoma are generally at a higher risk of developing this disease.

In India, women are found to be more prone to Glaucoma, especially angle closure Glaucoma, in which the forward bowing of iris blocks the outflow of aqueous humor suddenly resulting in severe headache, vomiting, redness and defective vision. These patients usually present initially to a general physician as headache and vomiting are predominant symptoms and a careful evaluation can identify the cause.

Clinical features and evaluation:

Since few glaucoma patients experience its symptoms from the beginning, early detection of the disease is generally difficult as most of them are **asymptomatic**. Some of the symptoms include defective vision, colored haloes, difficulty in side vision and redness with pain in few.

Any patient who is known to have risk factors mentioned earlier, are requested to have their regular eye check-up to prevent this blinding disease. A regular check once you turn 40 is a must. Besides the regular eye check-up for vision, what a person needs to get done is a comprehensive eye examination as well. Avoid refractive evaluation in an optical shop and ensure a detailed evaluation with an ophthalmologist, not only for refractive error but also to rule out various diseases like glaucoma, retinopathy etc.

A comprehensive eye test with an ophthalmologist includes a vision check-up, a slit lamp examination to assess any causative factors, an IOP (Intraocular pressure) measurement, gonioscopy (to visualize angle of the anterior chamber) and optic disc evaluation. All these indicators help us to determine the condition of the eye.

Once a patient is suspected to have glaucoma, these patients are subjected for further evaluation like visual fields (to assess peripheral field of vision), central corneal thickness measurement (to know the corrected/true intraocular pressure) and optical coherence tomography/OCT (to know the disc parameters and RNFL thickness all around). Based on clinical evaluation and results of further investigation, a decision is made to either treat or observe.

Management:

Management of glaucoma is not to reverse the damage already happened but its only to preserve what is left and prevent from worsening further. Even if you haven't reached the age of 40 but with strong family history, a regular eye check including test for Glaucoma is advisable.

While there is no cure for Glaucoma, elevated Intra Ocular Pressure (IOP) is currently the only treatable/modifiable risk factor. In case of angle closure disease, opening up the angle of anterior chamber should be the first step by means of YAG Laser Iridotomy (a 100-120

micron photo-disruptive laser assisted hole is made in the iris- which communicates between anterior and posterior chamber to prevent acute angle closure attacks).

Elevated intraocular pressure(IOP) either in open angle or in closed angle disease is managed with IOP lowering agents (Anti-glaucoma medications). These medications will either suppress the production of aqueous or increase the outflow through trabecular meshwork or through uveoscleral route. Outflow can also be increased via laser trabeculoplasty in case of open angle disease.

If the patients intraocular pressure is uncontrolled or disease is progressing despite maximal medical therapy (more than 3 or 4 anti-glaucoma medication), IOP reduction can be achieved by creating an alternative outflow pathway by means of various surgical modalities like Trabeculectomy, deep sclerectomy, implantation of anti-glaucoma valves(AGV) or MIGS (minimally invasive glaucoma surgery) with anterior chamber angle implants or procedures.

It is important to treat aggressively with the most effective modalities such as prescription eye drops that can provide maximum reduction of elevated IOP with long-term control. In some cases, surgery can also help. It is important for patients to use medication as prescribed and maintain regular follow-ups with an ophthalmologist, who can evaluate glaucoma progression and decide on treatment options.

As the **World Glaucoma Week** is observed internationally from **March 06th to 12th** this year (2022), I urge Indian Medical Association across various districts to commemorate this week and spread awareness about glaucoma among our medical fraternity and among public, to prevent this needless blindness.

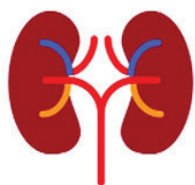

WORLD KIDNEY DAY

10, March

Dear seniors and friends,

World Kidney Day (WKD) is a global campaign initiated in 2006 aimed at creating awareness about role of kidneys in our overall health and reduce the frequency and impact of kidney disease worldwide. WKD is celebrated every second Thursday in March. There have been changing trends in the focus of theme and

objective over the past few years. The aim of the day is slowly moved towards the primary level rather than hit hard at the tertiary care level once the patient lands in chronic kidney disease (CKD) on dialysis. Here, I want to focus on the theme of WKD 2022 and a small view of the achievement of the Tamil Nadu government in the field of dialysis.

The 2020 theme was “Kidney health for everyone everywhere,” from prevention to detection and equitable access to care. Next, in 2021 it was “Living Well with Kidney Disease.” Joint Steering Committee has declared “Kidney Health for All” as the theme for the year 2022.

The campaign focuses on bridging knowledge gaps to improve kidney health through increased kidney care education and awareness in the public arena. The need for an increased understanding of the vital role of kidneys, and the simple ways of identifying and preventing potential health issues, can help combat unnecessarily high morbidity and mortality rates. Hence advancing knowledge of

kidney care requires involvement from the entire health community: health care providers, scientists, patients, administrators, health-policy experts, government officials, and kidney health organizations

Bridge the knowledge gap to better kidney care:

CKD is common and harmful: 1 out of 10 adult people worldwide have it. If left untreated, it can be deadly. It is projected to be the 5th leading cause of death by 2040. Early detection allows for disease care and management to help prevent morbidity and mortality and improve cost-effectiveness. A persistent and ongoing CKD knowledge gap exists, one that is demonstrable at all levels of healthcare;

At the community level, we need to break the obstacles to better kidney health understanding, including the complex nature of kidney disease information, minimal baseline awareness, health literacy, limited availability of CKD information, and lack of readiness to learn. At the healthcare level, we have to overcome another barrier and ensure greater awareness of physicians' more focused education, as they are in charge of the patients' medical condition. Public health policymakers globally are more committed to non-communicable disease programs concentrating predominantly on four primary diseases – cardiovascular disease, cancer, diabetes, and chronic respiratory disease. There should be stifling in the fight against kidney disease, which has inherently associated with mortality.

Other things to be focused on are to encourage the general public to adopt a healthy diet and lifestyle (access to clean water, exercise, healthy diet, tobacco control, and climate change prevention) to maintain good kidney health, preserve kidney function longer in those with CKD, and increase overall general awareness

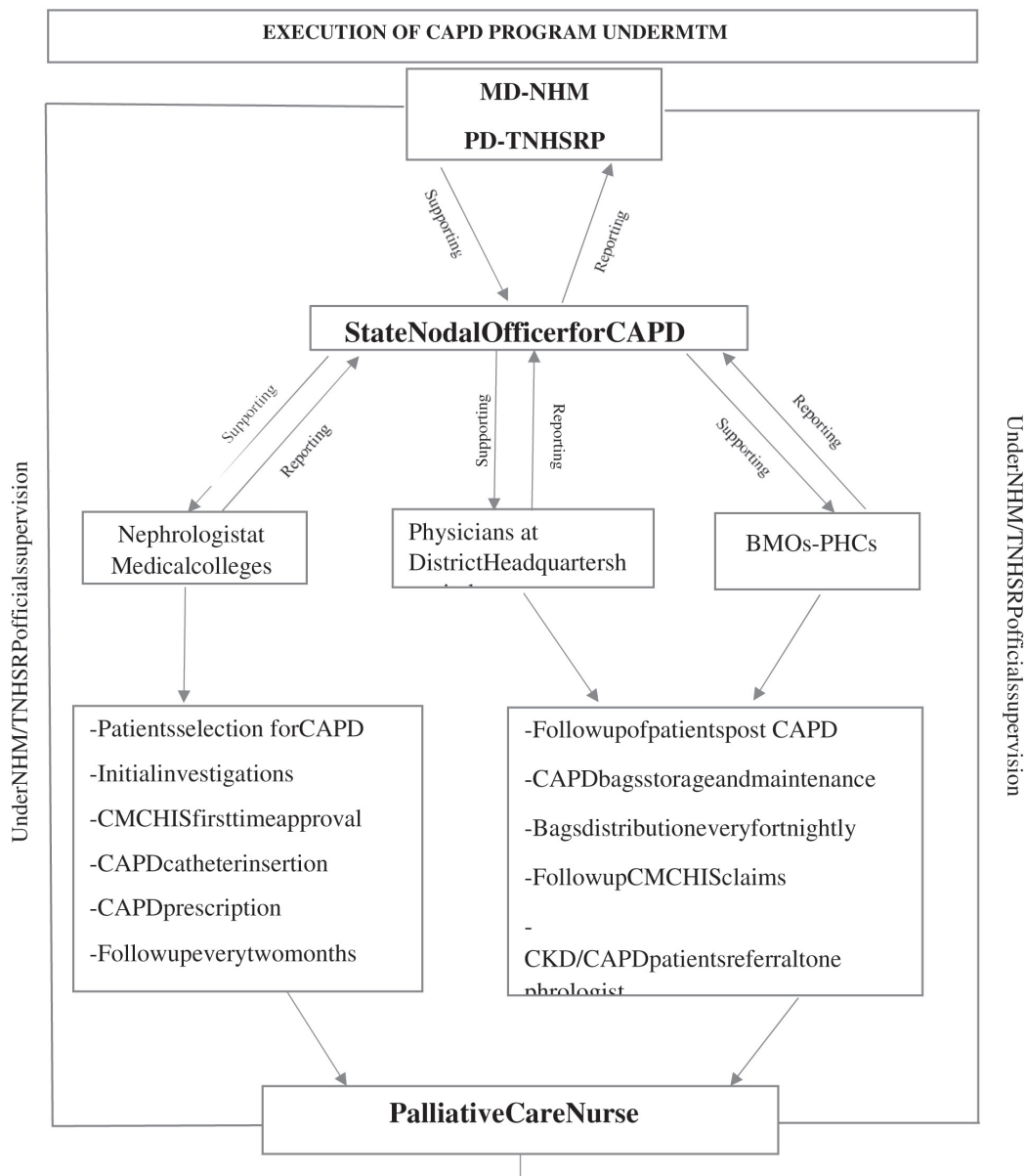
of the importance of kidneys. Recognize patients' and caregivers' right to assess, understand and use health information related to CKD. To inform the politicians about the impact of kidney disease and kidney failure on their constituents' health and its associated burden on healthcare budgets/systems to encourage the adoption of policies and allocation of resources that tackle the global burden of kidney disease and ensure living well with kidney disease.

Integrating CKD and kidney failure prevention into national non-communicable disease programs for comprehensive and integrated services is essential in improving the early detection and tracking of kidney care at the country level.

Makkalai Thedi Maruthuvam (மக்களைத் தேடி மருத்துவம்):

In Tamil Nadu, the health care delivery system has been always far advanced than any other state in India. Our policymakers have already made hemodialysis available even at headquarters, at the district level, and in the private sector through the chief minister's comprehensive health insurance scheme (CMCHIS). Even then, hemodialysis is not suitable for all patients. Those who are the family's breadwinners have to go to work at day times, and school going children due to the need for at least weekly twice hospital visits for the procedure. And also, in cardiac patients with poor LV function, those associated with hepatitis and HIV infection, and in patients with difficult vascular access. In these patients' continuous ambulatory peritoneal dialysis (CAPD) is the ideal choice. However, the cost of therapy would be around 25,000 INR per month. In early August 2022, Tamil Nadu chief minister honourable Thiru. MK Stalin launched the MTM program, which included home delivery of consumables and home care of all CKD patients

on CAPD. This program has brought a substantial and dynamic change in the care of CKD patients on dialysis in addition to the already existing chief minister health insurance scheme for hemodialysis.



We need to increase the awareness among the public on primary prevention and bolster the knowledge among health care providers for more and more attentive care in kidney disease. We should also help policymakers to implement more health programs. Focus on prevention, early diagnosis, prompt treatment at all health care levels, and good palliative care once the patient reaches ESKD. **Safe kidney, Safe Life!**

ஆ) 30 நாள் களிலேயே அவருக்கு ஒரு பதிவு அஞ்சலை மருத்துவக் கல்லூரி நிர்வாகம் அனுப்பியது. அந்தக் கடிதத்தில் 'மருத்துவர் எந்தவித ஒரு முன் அறிவிப்பும் இன்றி கல்லூரிக்கு வராததால், அவர்மேல் ஒழுங்கு நடவடிக்கை எடுக்கப்படுமெனவும், அவர் உடனடியாகக் கல்லூரிக்கு வந்து உரிய விளக்கத்தைத் தரத் தவறினால் அவர்மேல் சட்டப்படி நடவடிக்கை எடுக்கப்படுமெனவும், நஷ்டஈடு கோரப்படுமெனவும்' அந்தப் பதிவுத் தபாலில் கூறப்பட்டிருந்தது. மருத்துவர் முன் அறிவிப்பு இல்லாமல் கல்லூரிக்குச் செல்லாமல் இருந்தது ஒப்பந்தப்படி தவறு என்பதால், அந்த மருத்துவர் அதே தனியார் மருத்துவக் கல்லூரி மருத்துவமனையில் போய் பணி செய்ய வேண்டிய கட்டாயம் தற்போது ஏற்பட்டுள்ளது.

இ) ஒப்பந்தப்படி கல்லூரி நிர்வாகம் மாத ஊதியத்தை ரூபாய் ஒரு இலட்சத்திலிருந்து, 60 ஆயிரமாகக் குறைத்தபோதே அந்த மருத்துவர் உரிய முறையில் எழுத்துப்பூர்வமான தன்னுடைய ஆட்சேபணையைத் தெரிவித்துவிட்டு, சட்டப்படி தான் பணியில் தொடர விரும்பவில்லை என்பதற்கான எழுத்துப்பூர்வமான கடிதத்தை நிர்வாகத்திடம் கொடுத்திருப்பாரேயானால், அந்த மருத்துவர் கல்லூரி நிர்வாகத்திற்கு எதிராக வழக்குமன்றம் சென்று வெற்றி பெற்றிருக்க முடியும். ஆனால், அவர் அப்படிச் செய்யாததால் தனியார் மருத்துவக் கல்லூரி நிர்வாகிகளின் எதேச்சையான செயல்களை அவரால் தற்போது எதிர்க்க முடியவில்லையென்பதே இந்த மருத்துவரின் செயல்மூலம் நாம் கற்றுக்கொண்ட உண்மையாகும்.
