Respected seniors and my dear friends greetings. I hope and pray for your health and happiness. We are all fighting with COVID and we should continue this to conquer this invisible enemy.

On August 17th

Past presidents forum zoom meeting was conducted with single point agenda.

That is to get solatium from the State and Central Governments. Past Presidents whole heartily appreciated the work done by the State office during this pandemic I thank for the seniors appreciation. We passed the resolutions to Government.

AUGUST 18th

We had Emergency Executive Committee Meeting at Trichy. I Thank Trichy IMA for arranging it with all the protocols. We passed many important resolutions.

- Insisting the Government to sanction 50 lakhs solatium to the departed doctors family.
- IMA TNSB to give 2 lakhs to the family of doctors who died during the COVID pandemic. This would be done along with the Wings and Schemes contributions.
- Insisting Government to increase the number private labs for RT PCR and make sure the availability of antiviral drugs through out the State.
- 4. COVID Treatment packages should be revised by the Government.
- All IMA TNSB Trusts should be Re registered as per Government notification.
- Annual General Body Meeting should be fixed after discussing with the Registrar of Society.

Many of our members requested to appeal to TNMC on extention of time for updation and reduction in the penalty for not registering their additional qualifications. For which I have written a letter on 19th of August to TNMC. And the further I have

formed a high level committee to go on into these issues. Their recommendations have been represented to the Tamilnadu Medical Council. Now the Council extended the dates for 2 months. Hope they would reduce the penalty amount and make the procedure simpler.

On August 29th I once again had a video conference meeting with our Honorable Chief Minister Thiru Edappadi K Palanisamy. I have insisted to further relaxation of the lock down. To increase the private testing facilities, to be proactive in getting the vaccine for the Health care workers at the earliest when it is available. Also requested to give permission for plasma therapy in private sector. Once again appealed him to give solatium for Doctors families who have sacrificed their life in fight against COVID.

I appreciate IMACGP and AMS for conducting regular Webinar sessions with interesting topics. The attendance is good and I request them to use this opportunity to increase the membership.

We have received complaints from our members that Insurance companies forcing them to treat the COVID patients with the Government package rates. This we have taken

up and said that we cannot treat the COVID patients insured with the private insurance companies same as that of the Government rates. We had good and fruit full two rounds of discussion with Star Health Insurance and they have agreed for revised and better packages. I sincerely thank Dr.S.Prakash MD of Star Health Insurance and his team. I also thank Dr. A.K. Ravikumar, Dr. B. Sridhar, Dr. S.G. Balamurugan and Dr. S. Karthick Prabhu for their support and inputs. I request our members to await for the announcement for Star. By the time when you read this the new rates would be enforced for the entire State by the Star Health Insurance. I consider this is a milestone in the long term relationship with Star Health Insurance.

On 9th September I have received a call from the Project Director of TNHSP to once again submit the list of private Doctors died due to COVID with supporting documents. State Secretary immediately submitted the necessary documents to the Project director and to DMS for necessary action to claim for the Insurance amount of 50 lakhs under Pradhan Mandri Garif Kalyan Insurance package. Further details would be announced by the State office. I request the Branch presidents and Secretaries to provide necessary information and assistance to the family of Doctors to claim the Insurance amount.

We are requesting the Branch presidents and secretaries to apply for the Rs 2 lakhs solatium to the family of the Doctors died due to Corona with your recommendation and necessary documents with legal heirs certificates. Kindly contact State office for further information.

On 20th September after a long time we have the in person Management Committee meeting of FSS, PPLSSS and NHB at Erode.



Dear Friends

It gives me great pleasure to write you again as President Elect. Let us focus on issues at straight away. I have been already discussing issues related to PPLSSS accounts. In the previous edition I had demanded stem action against the manager of the guest house. Meanwhile the PPLSSS auditor, who went through the accounts has come out with certain observations.

Let me quote a few:

1. ROOM RENT COLLECTION: "A statement containing the room rent collections bill wise were jotted into a spread sheet and forwarded to the state office on monthly basis (Which means that she can manipulate the rental collection in whatever way she wanted). During my personal visit it was noticed that "manual Guest Ledger has been maintained as per the guidelines prescribed ONLY from March 2020". 2. CASH BOOK: Cash book was maintained and the *monthly expenses have been aggregated and entered on the last day of the month*. (Again an opportunity to mishandle money) *"The Physical cash Balance at any point of time could not be known under this system of accounting*. The canteen collections by cash are jotted in a chitta Ledger and held separately. *It is suggested that a common cash Book is maintained in columnar form* indicating room rent collections and canteen collections with their related expenses.

 SALARIES: Salaries are paid by cheques or NEFT to the Concerned employees a/c..
 The Overtime and extra wages paid is as per the computation of the manager and no further document in support of the working is produced before me for verification.

4. LAUNDRY EXPENSES: This expenditure is supported by *self created vouchers* only signed by the office manager and the employee. These are *not supported by the list of items laundered date wise*. Though a register is maintained to show the no. of items sent for laundry, in the absence of bills from the launderer regarding the no. of items laundered *it is not possible to verify the correctness and genuineness of the payments made to the launderer*. Moreover the items to be laundered is moved to Sankara Heritage for Laundry and the laundered items are moved back to JVL involving transport Charges 5. REPAIRS AND MAINTENANCE: These are verified with *self created vouchers* along with purchase bills of materials and vouchers signed by the workmen for receipt of labour charges. 6. STATIONERY: Rs. 47532/- in JVL and Rs. 1800 in GH. *The expenses under this head seems on the higher side at JVL*. On scrutinizing the bills, jottings, estimate slips etc., it is noticed that purchase of consumables like stateries for Remotes, Mosquito mats and fuels, soaps, hand wash sanitisers etc were purchased and included. It is not identifiable whether these purchases were for JVL alone or both the guest houses. *The Manager to Clarify*

7. CANTEEN EXPENSES: This expenditure is supported by *self created voucher* on the last day of the month signed by the manager and employee. The self created voucher is supported by numerous jottings for purchase of vegetables / provisions, purchased from petty shop owners. In some case *the jottings are illegible, such that the items purchased could not be identified*. All these jottings were totaled and attached to the *self created vouchers*. In some cases *totaling mistakes were made and excess claims made*. These mistakes were not checked by the office staff at Kallakurichi. In his further notings, the auditor has mentioned that 1. There is *an excess of expenditure of Rs. 1.23.000/- over income in the guest house accounts*. 2. There's *negative balance for consecutive five months* in the income - expenditure. 3. No accounts have been submitted for the month of March. You can see the auditor is not happy with many things happening in the guest house and demands that the manager needs to clarify. I again take this opportunity to demand the strictest action against the manager of the quest house of PPLSSS and seek immediate suspension of her from service. Also I recommend that a state coordinator with previous experience of working in PPLSSS accounts may be appointed to help the internal audit committee for rectification of the accounts until a new team of office bearers take over Next area of concern will be FSS. Already 70 deaths have occurred during this year and payment made. This has already been more than what has been collected as 25th advance. And we have four more months to go. We have three options:

1. Go for a floating method of collection in which the collected amount will vary from time to time depending on the number of deaths with Rs. 200 per death. (This is already stated in the bylaws of FSS). 2. Go for a fixed subscription of 100 deaths in a year (100x200) which is Rs.20,000/- per advance. 3. Third one will be to advance the 26th due to November. The above issue will be discussed in the forthcoming management committee meeting and also in FSC meeting on September 20, 2020.

FSS has been a great help to families facing financial trouble especially in the current pandemic situation and many said the money helped them pay the Hospital bills. It's our paramount duty to see to it that the scheme is kept viable by all means. In the current situation, the payments made to bereaved families outweigh the subscription collection and if this continues, the corpus fund will be eroded. Suggestions are welcome.

Last but not the least, the annual conference will take place as scheduled on 12th and 13th of December in Tirchy, and the number of participants will depend on the rules and regulations of the state government during the particular time. As of now, my Idea is to keep it strictly an official event and invite only the key office bearers- president, secretary and SCM members of a branch to the conference. The event will start with awards function in the afternoon post lunch, followed by the installation of the new office bearers. The SCM meeting will be held the next day. I intend to conduct the academic sessions as a separate event during a mid year conference by which time I hope we would have put an end to the pandemic effectively. Such a conference will be a grand gala event. This revised proposal will also be discussed on 20th September.

I take the opportunity to convey my best wishes to all the contestants who have filed nomination for the national elections. Ultimately it's a victory for democracy. Long live IMA.

World Alzheimer's Day 2020

Alzheimer's dementia day is celebrated worldwide on September 21st to create awareness and to educate the public and care givers. On this regard we are writing this article.

Introduction:

Dementia is a progressive neurodegenerative disorder characterised by gradual cognitive decline and functional deficits as well as behavioural changes. Four primary dementia classification have been used according to clinical and research

criteria. 1.Alzheimer's disease. 2.vascular dementia. 3. Fronto temporal dementia. 4.Dementia with Lewy body / parkinsons disease.

Alzheimer's disease accounts for 60% of all dementia. It is the most common and devastating neuro degenerative disorder.

It is a disease of old age often more than 70 yrs

It is associated with accumulation of amyloid and Tau deposition in the brain. Cognitive symptoms of Alzheimer's disease include short term memory loss, executive & visuo spatial dysfunction and Praxis. clinical assessment including mini mental state examination and other cognitive batteries remains critical for the diagnosis and staging. Amyloid imaging and genetics show great promise for facilitating for early

diagnosis and to differentiate from other neuro degenerative disorders. The needs of individuals affected by dementia are extensive and the management of the clinical syndrome is complex, extending beyond traditional bounds of medical practise. Dementia is characterised by significant impairments in multiple cognitive domain and behavioural changes. This places a tremendous burden on the individuals, carers and society.

CLINICAL FEATURES:

Mild cognitive impairment:

Clinical Alzheimers dementia is often preceded by prodromal phase called as mild cognitive impairment. This refers to minimal memory impairment with relatively preserved activities of daily living. The individuals with MCI progresses to alzheimers dementia rate of approximately 1-2% per year.

Three features are common to dementias. First is cognitive impairment including memory loss.

Short term memory loss is the most common feature of AD while long term memory, working memory and semantic memory will be preserved till the last stage. Word finding difficulty and executive dysfunction are also common early symptoms. Aphasia, apraxia, agnosia, attentional difficulties and executive functional impairment.

Neuropsychiatric symptoms comes as second. They are referred as behavioural and psychological symptoms of dementia(BPSD). They include depression, paranoid ideas. delusions. hallucinations, aggression and wandering. More symptoms include apathy, anxiety and irritability are also common, often provoked in challenging situations. Disturbances of appetite, disinhibition, hallucinations and delusions commonly occur at the later stages of dementia. DSM-5 criteria sets the diagnostic criteria for the diagnosis.

The third clinical feature includes deficits in activities of daily living(ADL). In the early stages of dementia impaired instrumental activities of daily life (IADL), may manifest including self neglect, poor eating, personal hygiene. Later on basic activities of daily living(BADL) are often impaired presenting with problems in dressing, eating and bathing.

Bio markers in Alzheimer's disease:

CSF amyloid and tau protein levels are most established AD biomarkers. CT scan or MRI of the Brain will exclude treatable disorders such as brain tumor, SDH and normal pressure hydrocephalus. Amyloid PET imaging is a recent advancement in the diagnosis of AD. This detects amyloid deposition even in prodromal stage. This imaging technique has high sensitivity and specificity.

Genetics:

APOE4 gene variant is the most established genetic risk factor for sporadic AD. One copy of the this genetic variant increases the odds for developing AD three fold and two copies increases the odds to 15 folds.

Treatment:

The management should include diagnostic and prognostic counselling to the patient at an early stage and also to the carers. It is important to encourage the patients to participate in social activities, day care centres and support groups.

Two classes of medications have been approved. The acetyl choline esterase inhibitors and NMDA receptor antagonists. Donepezil, Rivastigmine and galantamine. They should be started either alone or in combination in mild to moderate AD as per American academy of Neurology practice guide lines for dementia. All three of them shown to be effective in double blinded placebo controlled trials. It shows some benefit in memory and concentration as well as global and functional outcome measures. Side effects include nausea, vomiting and bradycardia.

Memantine, a NMDA receptor antagonist is an add on therapy to acetyl choline receptor antagonists. The main side effects are confusion and dizziness.

Associated depression can be treated with SSRI like citalopram. It has low anticholinergic effects. Agitation or disruptive behaviour require newer anti psychotic medications like quetiapine, risperidone and olanzepine. They are often started in lower dose and carefully titrated.

Future therapies:

The majority of current trials focus on interventions that directly influence the pathologic cascade of AD. One active immunisation trial has to be interrupted due to development of neuro inflammation in a patient. Current major efforts are focussed on passive immunisation as well as interfernce with B -amyloid and tau production and polymerization.

Conclusion:

AD is an irreversible neuro degenerative disorder. Although we are now able to diagnose AD in the early and prodromal stage we are still lacking preventative or disease modifying medications that can alter its course. 0

World Mental Health Day is observed on 10 October every year, with the overall objective of raising awareness of mental health issues around the world and mobilizing efforts in support of mental health.

The Day provides an opportunity for all stakeholders working on mental health issues to talk about their work, and what more needs to be done to make mental health care a reality for people worldwide.



Throughout the world millions of people are affected by arthritis, their lives being changed by the sometimes constant pain of inflamed joints. World Arthritis Day is a day to remember and raise awareness of this condition, and how it affects the lives of those that suffer with it. World Arthritis day was brought about by the Arthritis Foundation to do just that, and to encourage policymakers to help lower the burden of those suffering from Arthritis all over the world.

Arthritis is cleanly summed up in it's name, being derived from the greek words arthro, meaning joint, and itis, meaning inflammation. As the name implies it is a condition involving inflammation of the joints, but unlike the common conception that it is a disease all it's own, it is always a symptom of another affliction. Gout, Osteoarthritis, Rheumatoid arthritis, and Lupus are just some of the more common causes of this painful and often crippling condition.

Arthritis has been shown to have been with us as long as creatures have had bones, there's even evidence that ankle arthritis was present in dinosaurs by the study of fossils. Research has shown that it has been present in humans at least as far back as 4500 BC, and has been shown to be one of the most common afflictions of the prehistoric peoples. It was first closely examined and classified in William Musgraves work, De Arthritidesymptomatica, written in 1715.

For conditions such as rheumatoid arthritis and osteoarthritis, there is no cure, though there are often treatments that can be done. Largely these are basic health controls, including increasing exercise and working to reduce your weight. Other than that the usual treatments are pharmaceutical in nature and focus on reducing the pain of the condition rather than seeking to remove it.

Physical therapy has often been seen to be effective in helping, but the nature of the condition often impedes the implementation of such therapy. Motion hurts, but motion is shown to be among the best treatments. By keeping the joint mobile it helps to reduce the constant inflammation and has shown marked improvements in the long-term relief of the pain associated with it.


Many people associate this condition with the elderly and the health concerns that affect them, and statistical evidence supports that those over 65 are in fact the primary sufferers. But there is an often forgotten section of people who are under that age, almost 30% of all sufferers are under the age of 65, with some of them being no older than their teen years, and some rare cases existing even in the very young.

Take the time to educate yourself on this condition, and find the ways you can help prevent or hold-off this condition in your own life. 

Let us read about the importance of iodine in our diet, what happens due to iodine deficiency, how World Iodine Deficiency Day is celebrated?

World Iodine Deficiency Day is also known as Global Iodine Deficiency Disorders (IDD) Prevention Day. We all know that minerals and vitamins are necessary for our healthy life and play a crucial role in the physical and mental development of humans. Iodine is a mineral that is found in some foods.

What is Iodine and why it is necessary for our body?

Iodine is stored in the thyroid gland of our body and is an essential dietary mineral. It is important for our body as it helps in the production of thyroid hormones thyroxine (T3) and triiodothyronine (T4). Let us tell you that hormones of the thyroid gland affect mostly all the cells in the human body and are also important for the proper development of cells. It also helps In protein metabolism, increases metabolic rate of the body, regulate the growth of bones and development of brain. Basically, thyroid hormones are linked to protein, fat and carbohydrate metabolism in cells.

Iodine helps in regulating various functions of our body like

- Body temperature
- Breakdown of fat
- Growth
- Reproduction
- Muscle and nerve function
- Heart rate etc.

Various Glands and Hormones in Human Body

What is Iodine Deficiency Disorder (IDD)?

As the name suggests, the deficiency of iodine in the body may lead to serious illness. It can start before birth, jeopardise children's mental health and often their very survival. During pregnancy, serious deficiency of iodine can result in stillbirth, spontaneous abortion, congenital abnormalities like cretinism, mental retardation, etc. As we have discussed above, iodine is required for the synthesis of thyroid hormones, thyroxine (T4) and triiodothyronine (T3). It is also, essential for normal growth and development of humans. Do you know that around 100-150 micrograms, it is required by our body for normal growth?

Deficiency of Iodine

- Mental retardation
- Goitre
- Still birth
- Hypothyroidism
- Subnormal intelligence
- Neuromuscular weakness
- Defect in vision, hearing and speech
- Spasticity
- Intrauterine death etc.

Sources of Iodine

- Milk
- Meat
- Sea Fish
- Shellfish
- Eggs
- Cereal grains
- Salt
- Yogurt
- Sea vegetables
- Vegetables and Fruits etc.

WHO regarding IDD

WHO, since 1980s has been working for public health around the world and also to eliminate the deficiency of iodine. For this WHO provides guidelines, technical tools, methodologies and technical guidance to build up national salt iodization programmes. UNICEF, ICCIDD (International Council for Control of Iodine Deficiency Disorders), some international and bilateral agencies are also together working to combat with the iodine deficiency. We can't ignore that various salt agencies have helped countries to set up a permanent national salt and iodization programmes.

In 1993, for controlling IDD, a primary intervention strategy that is universal salt iodization was adopted. Salt is widely available and consumed in regular forms throughout the year so, it is chosen and the cost of iodizing is also extremely low per person per year.

In most of the countries where iodine deficiency is a public health problem, strategies are implemented against IDD.

Some facts regarding Iodine Deficiency

- Iodine deficiency can cause impaired cognitive development in children.
- Countries where iodine deficiency is a major concern has been halved now from the past according to a new global report on iodine status.
- According to WHO, approx 54 countries are still iodine-deficient.
- Sustainable salt iodization programmes are necessary to strengthen.

So, we can say that it is necessary to take iodine in our diet. But excess of everything is bad. It should be taken in proper quantity as required by our body. \bigcirc

EXISTING REGISTERED MEDICAL PRACTITIONERS-NOTIFICATION FOR REGISTRATION NUMBERS 40001-75000

A notification was issued on 18th May 2020 by the Tamilnadu Medical Council directing all the Registered Medical Practitioners (Registered in TNMC on or before 05.01.2020) to update their credentials online and obtain fresh e-certificates of their registered degrees.

This notification was issued, based on directions issued by the Medical Council of India, on the subject of bringing about uniformity, among state medical councils, in renewal of registration of registered medical Practitioners. Also, MCI directed contribution from the State Medical Councils for creation of "National Digital Medical Registry" as part of National Digital Health Mission.

This process was started in a phased manner, and in the first phase the RMPS with registration number between 15000-



40000 were directed to mandatorily update their credentials on or before 31st August 2020. Based on representation by individuals and IMA and due to Covid19 pandemic, the time frame is being extended up to 31.10.2020.

In the second phase, the Tamilnadu Medical Council directs, RMPS with registration numbers between 40001 to 75000 to mandatorily update their credentials for creation of "State Digital Medical Register" and obtain their e-certificates on or before 31.01.2021.

All RMPs are requested to cooperate in this digital update.

07-08-2020 இல் அந்தத் தாய்க்கு இரவில் கடும் வயிற்று வலியும், உதிரப்போக்கும் ஏற்பட்டது. 08-08-2020 அன்று Scan செய்யப்பட்ட போது Mildly thickened Endometrium என ரிப்போர்ட்டில் வந்துள்ளது. மகப்பேறு மருத்துவர்களாகிய நீங்கள்தான் Early Pregnancy Loss அல்லது False Pregnancy என்பதற்கான விளக்கத்தை அளிக்க வேண்டும். தக்க ஆதாரத்துடன் விளக்கம் அளித்தால் வழக்கறிஞர் நோட்டீசிற்கான பதிலைத் தயாரிக்க அந்த மருத்துவருக்கு எளிதாகும்.
