Dear Seniors friends and colleagues,

A short recap of last month's events.

We had the Maruthuva Natchathiram Award function on 16th August 2022, attended by the Hon'ble Health Minister, an event where we had a lot of time to represent various issues to him. Also met the Health Minister on 22nd August, where we again represented about the closure of Hospitals. We cannot accept and strongly objected this kind of closure of the entire Hospitals which is an institution where so many people work and depend on.

Any kind of action initiated can only be done after consultation with the district CEA committee and the state CEA Committee, if the action is drastic. We from IMA are a member of the District and State Committee and hence should demand that the meeting takes place atleast once in 3 month.

The recent Fire Safety Rules and Regulations which have been issued are Hospital friendly, but the validity of the certificate should be extended to 5 years.

The Government Schemes package rates are very low and the rates need to be increased to be viable for the Hospital and Doctor.

The Award Ceremony in Madurai attended by Hon'ble Thiru P.T.R. Palanivel Thiagarajan, Hon'ble Minister for Finance & Human Resources Management who gave us time to interact with him and as the Health Scheme for the Government Employees and pensioners fall under his ambit we represented that too and he has promised us time to discuss this issue. I was proud and honored as we were studied in the same School- Lawrence School Lovedale, and share a relationship over three generations.

The Award Ceremony in Tiruchirappalli, again well attended and chaired by Hon'ble Thiru. K.N. Nehru, Hon'ble Minister for Municipal Administration, Urban and Water Supply who gave us time to interact and request for reduction of taxation rates for Hospitals and Nursing Homes and for prompt removal of solid waste from our premises, which again was accepted by the Minister; need to follow up with everyone on all requests.

The West Zone Award Ceremony held at Coimbatore with our fraternity member & Hon'ble Minister Dr. M. Mathiventhan, Minister for Tourism as Chief Guest went on well. He was also concerned about all the issues we talked about and promised that he would talk to the Ministers concerned and also arrange and come with us for the discussions and meetings.

The proposed Constitution of our IMA TNSB has been posted in our website, we request you to go through it and give your comments, observations and any changes to the State Office at the earliest. It would be passed in the 80th General Body Meeting of IMA Tamilnadu State Branch will be held on 28th September 2022 @ IMA Hall, Tiruchirappalli - 11.30 a.m. onwards.

Finance Standing Committee meeting was held on 07.08.2022 at JVL Plaza, Chennai. Accounts of IMA TNSB, Schemes and Wings of IMA were scrutinized with bank accounts, bills and Vouchers. All accounts were maintained well.

The Following decisions were taken in the FSC Meeting.

1. An Account should be opened in the name of MSN & JDN under IMA TNSB which will be operated jointly by the Chairman of MSN & JDN and Finance Secretary of IMA TNSB.
2. Likewise, the accounts of various wings such as Paramedical, CGP of IMA TNSB and AMS, should be operated jointly by the concerned wings secretaries and Finance Secretary of IMA TNSB. FSC requested the Constitution Amendment Committee of IMA TNSB to incorporate the above changes in constitution and which will be submitted in the forth coming State Council, for its due approval.
3. Due date for the renewal of NHB membership shall hereinafter be the immediate next day of respective joining dates of members, instead of now being the First January.
4. It is highly appreciated that the Fixed Deposits were increased in FSS I & II which was a good sign of the stability of the scheme. All endeavors should be made to multiply the FSS membership in the larger interests of the scheme.
5. Similarly, membership strength should be increased in PPLSSS, HPS & FBS. The rate of occupancy of both Guest Houses is tend to be enhanced and all rooms available in both Guest Houses should be properly preserved to encourage the pleasurable habitation.
6. Rs.50,000/- Should be sanctioned for the treatment of Past President Dr.P.K.Kesavan from IMA TNSB endowment account.

Theme of the World Lung Day is Lung Health for all.

Aims of the Healthy Lungs for life campaign

1. Increase knowledge of the impact of poor air quality on lung health and the actions that everyone can take to reduce air pollution and avoid exposure.
2. Highlight the benefits of quitting smoking.
3. Increase knowledge of the importance of physical activity for lung health.
4. Raise awareness of vaccination to prevent lung infection.

Air pollution is an important risk factor for majority of the Respiratory diseases. Polluted air inhalation leads to allergic, asthmatic bronchitis, COPD, lung cancer and lung infections. Avoidance of allergens, minimize exposure or avoid exposure of polluted air is the primary prevention of majority of the Respiratory disease. Air pollution induced lung diseases are majoritily preventable disease.

Tobacco cessation is an important primary prevention for Chronic Obstructive Pulmonary Disease (COPD), Lung cancer, Interstitial Lung Disease and Asthma exacerbation and infections. Tobacco cessation program has effective counselling and medical therapy mainly nicotine replacement using gum and patch and oral therapy.

Physical activity mainly brisk walking, cycling, swimming, aerobic exercises, breathing exercises like



pranayama will increase lung capacity. In pulmonary disease individuals like COPD,ILD the pulmonary rehabilitation program plays a major role in improving quality of life and individual performance status.


Respiratory vaccines are important primordial prevention for pneumonia. As per the recommendation of World Health Organization (WHO) and Centre for Disease Control (CDC) we follow the vaccination program in adult (Adult Vaccination)


Annual flu shot for Influenza viral infection (H1N1-swine flu) preferably before monsoon ideally in August and September.

Pneumococcal vaccination to start with Pneumococcal Conjugate Vaccine 13 (PCV-13), 3 to 6 month later Pneumococcal polysaccharide vaccine-23 (PPV 23) one shot and booster dose of PPV-23 after 5 years.

Pertussis vaccine one dose and Herpes Zoster vaccine 2 doses and COVID 19 vaccination as per the WHO and ICMR guidelines.

This adult vaccination is for all adult 50 plus age and less than 50 age with comorbidities like chronic disease individuals, frequent traveler and health care providers. COVID appropriate behavior (SMSV-Sanitization, Mask, Social distancing and Vaccination) not only protect the COVID 19 but it prevent other infectious disease like Flu, TB, Pneumonia and allergic diseases.

Whilst the pandemic has, and continues to, take its toll on our mental health, the ability to reconnect through World Mental Health Day 2022 will provide us with an opportunity to re-kindle our efforts to protect and improve mental health. Many aspects of mental health have been challenged; and already before the pandemic in 2019 an estimated one in eight people globally were living with a mental disorder. At the same time, the services, skills and funding available for mental health remain in short supply, and fall far below what is needed, especially in low- and middle-income countries.

The COVID-19 pandemic has created a global crisis for mental health, fuelling short- and long-term stresses and undermining the mental health of

millions. Estimates put the rise in both anxiety and depressive disorders at more than 25% during the first year of the pandemic. At the same time, mental health services have been severely disrupted and the treatment gap for mental health conditions has widened. Growing social and economic inequalities, protracted conflicts, violence and public health emergencies affect whole populations, threatening progress towards improved well-being; a staggering 84 million people worldwide were forcibly displaced during 2021.

Stigma and discrimination continue to be a barrier to social inclusion and access to the right care; importantly, we can all play our part in increasing awareness about which preventive mental health interventions work and World Mental Health Day is an opportunity to do that collectively. We envision a world in which mental health is valued, promoted and protected; where everyone has an equal opportunity to enjoy mental health and to exercise their human rights; and where everyone can access the mental health care they need. ●

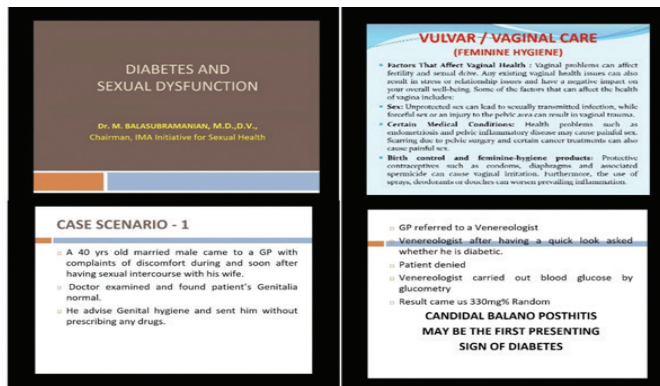

காவல்துறை அந்த மகப்பேறு மருத்துவருக்கு எதிராக FIR பதிவு செய்ததைத் தொடர்ந்து, இணை இயக்குநர் மகப்பேறு மருத்துவமனையை மூடி 'சீல்' வைக்கும்படி உத்தரவிட்டார். அதைத் தொடர்ந்து மகப்பேறு நிர்வாகம் சீலை அகற்றும்படி கோரிக்கை வைத்தும், அதை இணை இயக்குநர் ஏற்க மறுத்ததை அடுத்து மருத்துவமனை நிர்வாகம் சென்னை உயர்நீதி மன்றத்தை அணுகியது.

உயர் நீதிமன்றம் 05.09.2022 இல் கொடுத்த தீர்ப்பை உங்கள் முன் படைக்கிறேன்.

1. வழக்கு விசாரணையின்போது இணை இயக்குநர் தன் வாதத்தில் அரசின் அங்கீகாரம் பெறாமல் கருச்சிதைவு செய்தது Medical Termination of Pregnancy Act, 1971க்கு எதிரானது எனவும், ஆகவேதான் Medical Termination of Pregnancy Act, 1971 மற்றும் Tamilnadu Clinical Establishment Act, 1997ன்படி அந்த மருத்துவமனைக்குச் 'சீல்' வைத்ததாகவும் வாதிட்டார்.

2. மருத்துவமனையின் நிர்வாகம் சார்பாக வாதிட்ட வழக்கறிஞர், அங்கீகாரம் பெறாமல் கருக்கலைப்புச் செய்தது தவறாகக் கருதப்பட்டாலும், அதற்காக FIR பதிவு செய்யப்பட்ட நிலையில் Tamilnadu Clinical Establishment Act, 1997ன் படியும், Medical Termination of Pregnancy Act, 1971படியும் மருத்துவமனையை முழுமையாகச் 'சீல்' வைத்து மூட அரசுக்கு அதிகாரம் இல்லை என வாதிட்டார்.

3. மேற்கண்ட வாதங்களை விரிவாகக் கேட்டுக்கொண்ட உயர் நீதிமன்றத்தின் நீதிபதி கனம் N. STHISHKUMAR அவர்கள் கொடுத்த தீர்ப்பின் பாராக்களான 9,10,11,12,13,14 ஆகியவற்றை, குறிப்பாக மகப்பேறு மருத்துவர்களின் பார்வைக்காக அப்படியே கீழே கொடுக்கிறேன்.

9. Be that as it may. Section 6 of the Medical Termination of Pregnancy Rules, 2003, reads as follows:

(1) A place approved under rule 5 may be inspected by the Chief Medical Officer of the District, as often as may be necessary with a view to verify whether termination of pregnancies is being done therein under safe and hygienic conditions.

(2) If the Chief Medical Officer has reason to believe that there has been death of, or injury to, a pregnant woman at the place or that termination of pregnancies is not being done at the place under safe and hygienic conditions, he may call for any information or may seize any article, medicine, ampoule, admission register or other document, maintained, kept or found at the place.

(3) The provisions of the Code of Criminal Procedure, 1973 (2 of 1974), relating to seizure, so far as it may, apply to seizure made under sub-rule(2).

10. Above section deals with Inspection. Rule 7 of the Medical Termination of Pregnancy Rules, 2003 deals with the cancellation or suspension of certificate of approval in the event of violation. The Medical Termination of Pregnancy Rules and Act, do not provide the source of power to completely seal the hospital. Admittedly, the petitioner is a medical practitioner and her clinic was established under Tamil Nadu Clinical Establishment Act, 1997, after approval, which is also not disputed. Section 5 of the said Act

deals with Suspension or cancellation of registration, which reads as follows:

“5. Suspension or cancellation of registration.-

(1) Where the holder of a certificate of registration of a clinical establishment has been convicted under any of the provisions of this act for three times in the aggregate, the competent authority shall cancel the Certificate of Registration and the clinical establishment shall not be permitted to apply for fresh registration.

(1-A) The competent authority may, suo-moto or on complaint, issue a notice to any private clinical establishment to show cause why its registration under this Act should not be suspended or cancelled for the reasons mentioned in the notice.

(2) If after giving a reasonable opportunity of being heard to the clinical establishment, the competent authority is satisfied that there has been a breach of any of the provisions of this Act or the rules made there under or the conditions of registration, it may, without prejudice to any other action, that it may take against such Private clinical establishment suspend its registration for such period as it may think fit or cancel its registration:

Provided that where the competent authority is of the opinion that it is necessary or expedient so to do in the public interest, it may, for reasons to be recorded in writings suspend the registration of any private clinical establishment without issuing any notice.”

11. On a careful perusal of the above provision makes it clear that the competent authority has power either to cancel or suspend the registration of the clinics. Whereas in this case, the competent authority has not suspended the licence of the hospital. When the statute provides only for suspension or cancellation of licence, without resorting the power available under law, when the clinic was established after approval, the respondent cannot seal the premises without resorting the provisions available under law permanently. As long as the Petitioner is a medical practitioner, her licence has not been cancelled,

she is entitled to continue her medical profession. Though she has violated certain provisions of law for which she has been separately prosecuted and in the event she being found guilty, the law will take its own course to punish the Petitioner for such violation. But the question arises in this case is that having initiated the prosecution whether the petitioner still could be deprived of her profession permanently, without resorting any lawful measure as provided in both enactments, either to cancel or to suspend the licence. Having not adopted such procedure, this Court is of the view that, permanent sealing of the premises established after approval will in fact infringe the fundamental right of the person to carry out the profession.

12. Though the learned Additional Public Prosecutor relied upon the Division Bench judgment of this court in W.A.Nos.1758 and 1759 of 2022. The above case is with regard to the temporary suspension of registration of the licence granted to the hospital which was challenged before the Division Bench. The Division Bench after considering the provisions of the Act has held that temporary suspension of the licence of various hospitals committed various violations including extraction of oocyte from the minor girl cannot be set aside. Therefore, the above judgment is not applicable to the fact of this case. But here it is not the case of suspension of registration of licence granted under the Tamil Nadu Private Clinical Establishment Act, 1997. Whereas, the authorities have straightaway sealed the premises. Such thing is not permissible without the source of power under statute.

13. Accordingly, the Order of the Respondent sealing the premises Permanently, is set aside and the Respondents are directed to de-seal the premises forthwith.

14. In the result, the Writ Petition is allowed. No costs. Consequently, connected Miscellaneous Petition is closed.

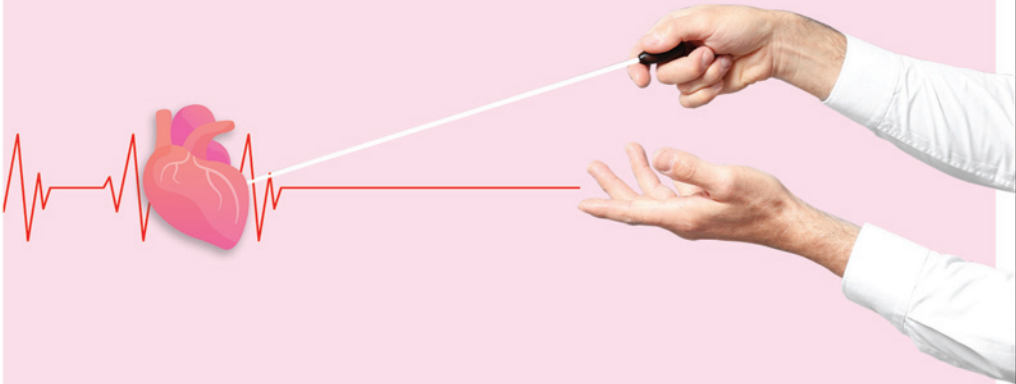
